## RE: 1185 Dager Rd

Property Maintenance and Housing Standards [Ordinance 692] requires all properties sold in Warminster Township to obtain a Use and Occupancy Certificate.

Please be advised the Use and Occupancy inspection conducted at the above referenced property has <u>FAILED</u>.

- 1. **Electrical Certification:** Submit to Township a copy of the Electrical Certification performed by a certified Electrical Underwriter.
- 2. **Smoke Detectors: IPMC15 704.2** Smoke detectors are required on each level, in each sleeping room, in the basement and in each basement room separated by a door. Devices shall be UL listed.
- 3. **Detached Structures: IMPC15 304.1** Detached structures such as garages, carports and sheds shall be in structurally sound and in good repair.
  - a. Shed doors require repairs.
- 4. **Exterior maintenance: IPMC15 302.4** Exterior grounds are to be free of debris. Lawns and landscaping are not to be overgrown.
  - a. Exterior back door light fixture must be secured to exterior.
- 5. **Roof/Drainage: IPMC15 304.7** Roofing and flashing shall be weather-tight Gutters and downspouts shall be maintained
  - a. Gutters require cleaning.

- 6. **Exterior Walkways and Sidewalks: IPMC15 302.3** Exterior walkways, patios and driveways are to be in good repair. Public sidewalks, curbs and driveway aprons (within the street right-of-way). All public walkway replacements require a Concrete Application and Permit.
  - a. 7 Sidewalk blocks 4ft x 5ft
  - b. 1 Apron Block 4ft x 8ft
  - c. Regular Curbing 10ft
  - d. Repair tripping hazards on driveway
