## QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, Joe T. Robinson, Jr., a single person; Alvin Robinson, a single person; A. T. Robinson and Edith Rye Robinson, his wife; Ethel Christian; Willie F. Holland; and W. T. Robinson and Willie B. Holland, Executors and Trustees under the last will and testament of J. F. Hicks, deceased; for and in consideration of the sum of One and No/100 DOLLARS (\$1.00), to us in hand paid by THE CITIZENS BANK OF ENGLAND, Arkansas, the receipt of which is hereby acknowledged, do hereby grant, convey, sell and quitclaim unto the said THE CITIZENS BANK OF ENGLAND, Arkansas, and unto its successors and assigns forever, all our right, title, interest and claim in and to the following land lying in Lonoke County, Arkansas:

Part of Lot Two (2), Block Forty-nine (49), City of England, Arkansas, more particularly described as follows:

Beginning at a point on the East line of Lot Two (2), Block Forty-nine (49) and Six (6) Feet South of the Northeast Corner of said Lot Two (2), Block 49; thence South along the East line of said Lot Two (2), Block 49, a distance of Nineteen (19) feet to the Southeast Corner of said Lot 2, Block 49; thence West along the South line of said Lot 2, Block 49, a distance of Ninety (90) feet; thence North a distance of Nineteen (19) feet; thence East a distance of Ninety (90) feet to the East line of Lot 2, Block 49, and POINT OF BEGINNING.

ALSO: A right-of-way or easement over, upon and across Lot Two (2), Block Forty-nine (49), City of England, Arkansas, for the purpose of ingress and egress to the above described lands, more particularly described as follows:

Beginning at the Southwest Corner of lot Two (2), Block Forty-nine (49), City of England, Arkansas, thence East along the South line of said Lot 2, Block 49, a distance of Fifty (50) feet; thence North a distance of Three (3) feet; thence West a distance of Fifty (50) feet to the West line of Lot 2, Block 49; thence South along the West line of said Lot 2, Block 49, a distance of Three (3) feet and POINT OF BEGINNING,

Part of Lot One (1), Block Forty-nine (49), City of England, Arkansas, more particularly described as follows:

Beginning at the Southeast Corner of lot 1, Block 49, thence North along the East line of said Lot 1, Block 49, a distance of Five (5) feet; thence West a distance of Sixty (60) feet; thence South a distance of Five (5) feet to the South line of lot 1, Block 49; thence East along the South line of lot 1, Block 49, a distance of Sixty (60) feet and POINT OF BEGINNING.

# THE STATE OF ARKANSAS

To All to Whom These Presents Shall Come—Greeting:

KNOW YE, THAT WHEREAS, by an Act of Congress of the United States of America, entitled "An Act to enable the State of Arkansas, and other States, to regulate the Swamp and Overflowed Lands within their limits," approved 2d of September, 1850, all of such Swamp and Overflowed Lands were granted to the State of Arkansas; and Whereas, under the provisions of the Act of the General Assembly of the State of Arkansas, regulating the price and sale of lands so granted, the

Commissioner of State Lands for the State of Arkansas, did grant this Deed or Certificate dated the 31st day of December, 1962, and numbered 13557

to, and in favor of, his heirs and legal representatives of Peter W. Hicks

Dwelling, in City of the Original Certificate dated the 15th day of April, 1859, for  
the following described lands, as follows:

Southeast Quarter of Southwest Quarter (SE $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section Eleven (11)

in Township Three (3) North at the house line, in Range Nine (9) West

of the Fifth Principal Meridian, containing 40.00 Acres  
and said lands having been patented by the United States to the State of Arkansas, as a portion of the Swamp and Overflowed Lands  
granted to the said State by the Act of Congress aforesaid, and the purchase money for said lands amounting to

Twenty Dollars and 80 Cents, having

been fully paid, therefore the said heirs and legal representatives of Peter W. Hicks  
Deceased, are entitled to a Deed from the State of Arkansas for the said land.
