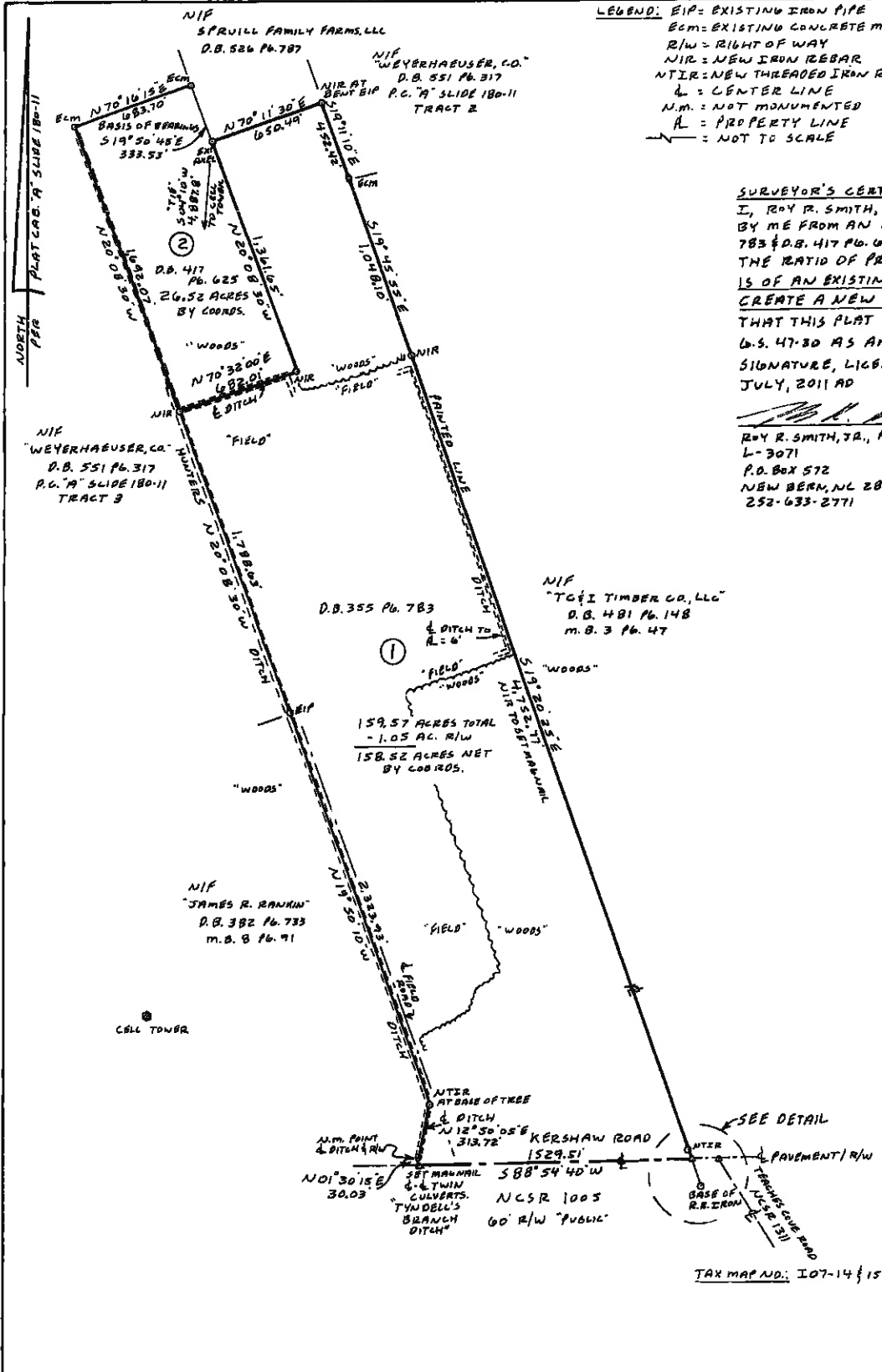


# Plat Cabinet A Slide 183-20

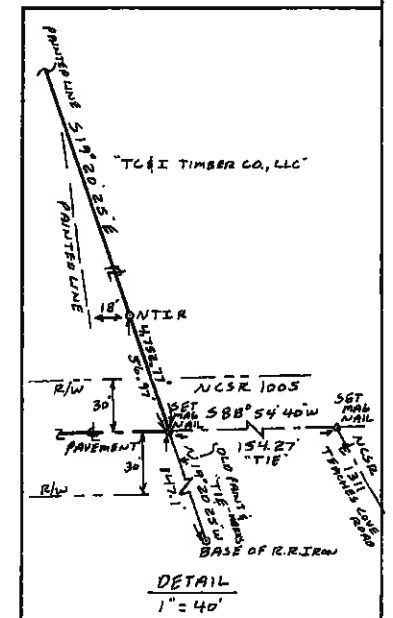
