- 2. In order to be entitled to any commission/referral, the Broker must:
  - A. Register his or her client by completing the Brokers Compensation Program Registration Form in full including the signature of the client on the form.
  - B. Submit the Broker Compensation Program Registration Form via email to <a href="mailto:auctioninfo@targetauction.com">auctioninfo@targetauction.com</a> for receipt before the deadline of <a href="mailto:24">24 hours prior to Auction Day</a>. Broker forms arriving after the deadline will not be honored. Broker Registration forms sent anywhere other than the email address above will not be honored.
- 3. The Broker, by placing his or her signature below, certifies, agrees, and acknowledges that:
  - A. The Broker will not claim any exceptions to the procedures outlined in this document unless made in writing and signed by Seller.
  - B. No oral registration will qualify Broker for commission/referral.
  - C. The Broker's commission/referral will be due at the final closing of the property(s) purchased by the Broker's client after all consideration is paid in full.
