1. House Systems (a) Plumbing: Pinhole pipe repairs several years ago. In August, 2017, Valve leak in the basement required replacing carpeting and other repairs. Work done by Paul Davis Co.
2. House Systems (c) Appliances: basement dishwasher and refrigerator not hooked up.
3. Foundation/Structure/Basement (c) Basement leaking: Approximately 5 years ago a disconnected rain spout caused some minor basement leakage, since repaired.
